Our Mission:

CASA of Missoula provides independent, trained advocates for the best interests of children within the judicial system who are at substantial risk or have experienced abuse or neglect. We provide consistent, long-term advocacy until every child resides in a safe, permanent home.

OUR NUMBERS



Volunteers served **312 children** in Missoula and Mineral County courts due to abuse and neglect (out of 381).



CASA of Missoula's **144 volunteers** dedicated over **4,380 hours** to advocating for abused and neglected children.

NEW CASA VOLUNTEERS



CASA of Missoula trained **46 new advocates** and swore them into the 4th Judicial District Court.



CLOSED CASES

124 Dependency Neglect cases **closed** with the help of a CASA volunteer.

Of all closed cases, **60% reunified with parents**, **22% completed an adoption or guardianship with relatives**, and **15% were adopted by non-relatives**.

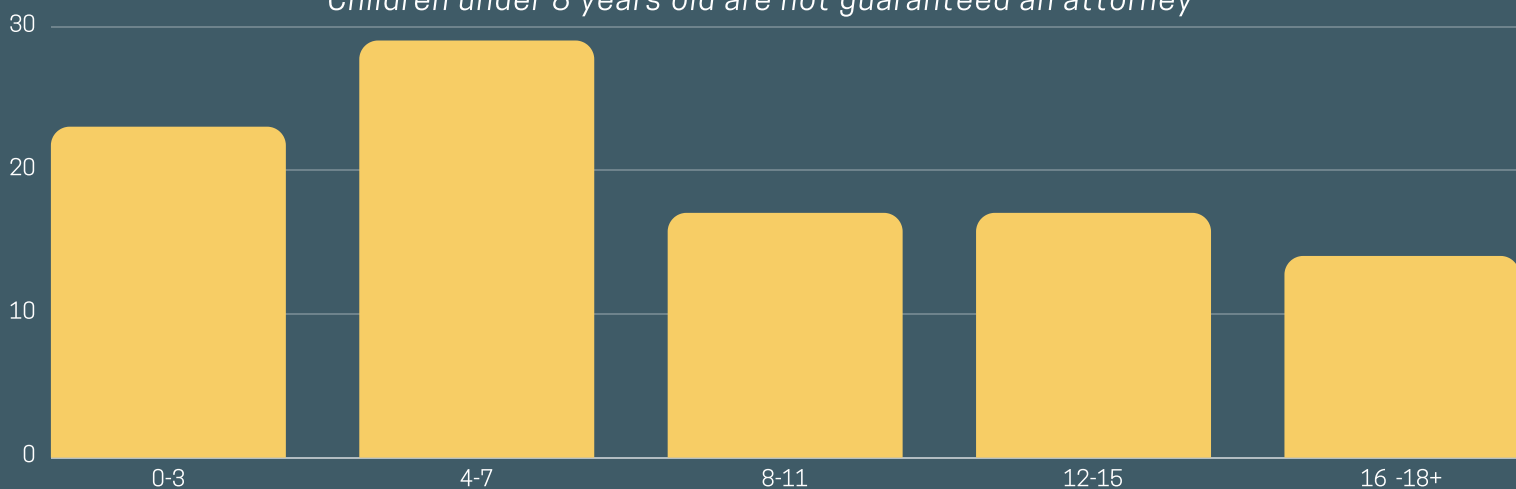
CASA TRAINING



After a pre-screening interview, CASA volunteers must complete 30 hours of training and about 10 hours of outside coursework over 5 weeks to become a volunteer. They also must pass a background check, and complete 12 hours of continuing education annually to stay active. New CASA volunteers are paired with an experienced CASA mentor the first three months on their case.

**Children under 8 years old are not guaranteed an attorney*



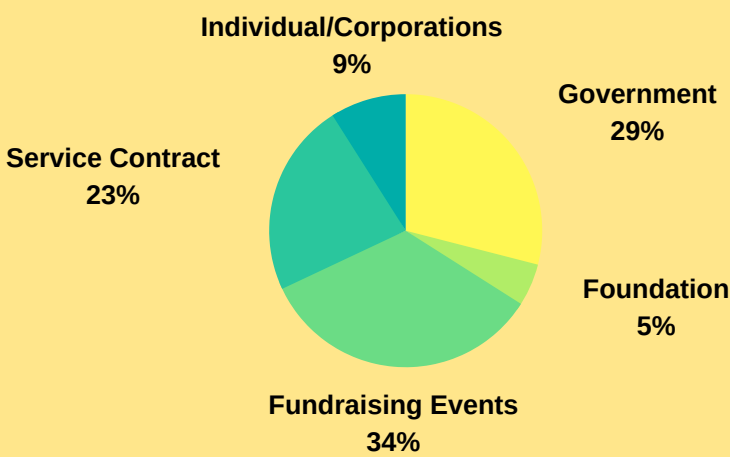

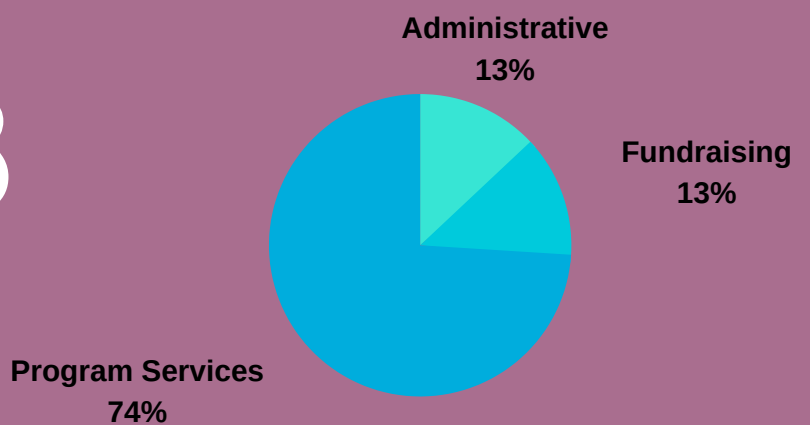
