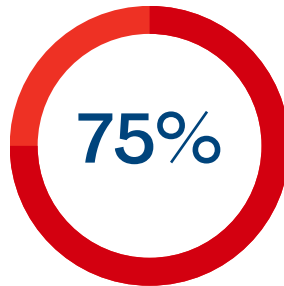

CASA volunteers served 75% of children in Missoula and Mineral County with an open Dependency & Neglect case.



78 New Children Received a CASA

78 new children with abuse and neglect cases were assigned a CASA this fiscal year.

3,675 hours of their own time.

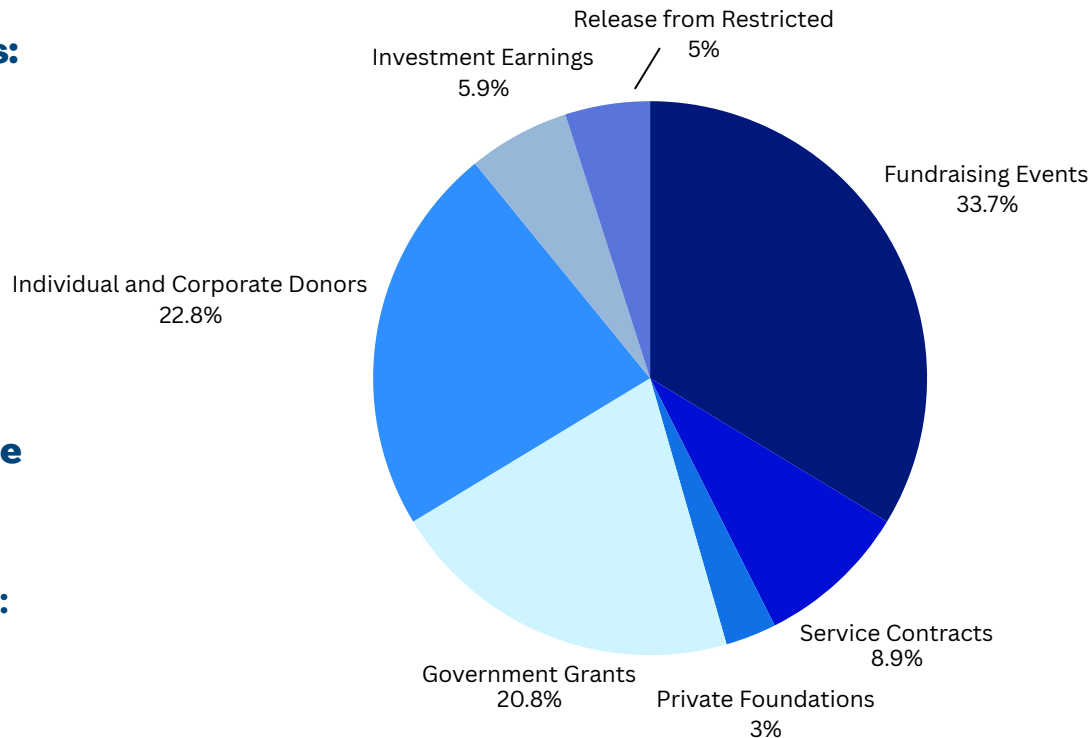

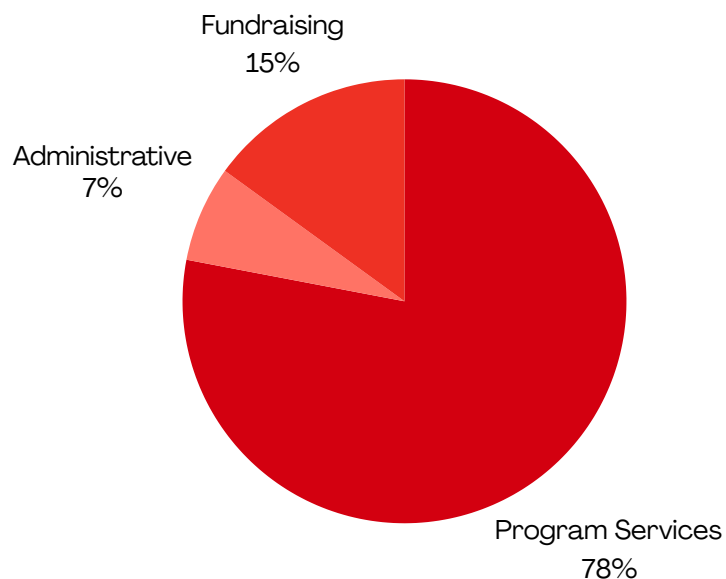

A TRUE STORY OF CASA IMPACT: JEN AND ALYSSA

Born while her mother was incarcerated, Alyssa spent her childhood in and out of foster homes, a ghost in her own life. "Normal"—the life of stability she saw in her classmates—was a feeling she feared she'd never have. By age 14, both her parents' rights had been terminated. At 16, a runaway and addicted to alcohol, Alyssa was put in Juvenile Detention after an incident involving other teens. Her sentence was substantial, as she had nowhere else to go.



Jen, Alyssa's CASA, visited her often. As a member of Alyssa's legal team, Jen was allowed access to Alyssa while incarcerated, and through that, could offer Alyssa a type of bond she'd never had. **Jen became the first adult Alyssa had met who was a steady support, someone forever in her corner.**

Alyssa found in Jen a person who finally believed in her, and that belief gave Alyssa the courage she needed to forge a new path for her life. Suddenly, Alyssa wasn't just surviving; she was thriving. Last spring, Alyssa graduated from high school with an award, earned by an essay she wrote on the Foster Youth-to-Prison Pipeline. She is now a freshman studying Sociology at Montana State University. **She and Jen still talk multiple times per week, as they both say: "Best Friends For Life."**
